#### Faculty Senate Vol. XIX-30 Minutes of June 19, 1990

## III. Old Business:

A. The Coleman Annex has been named Lumpkin Hall (Marlow).

B. Gosselin reported on the files of the Distinguished Faculty Awards applicants. There is a question as to what to do with them. They should be retained for one year (Fewell). However, some faculty might want materials for promotion portfolios (Miller).

C. The letter from the Faculty Senate expressing no-confidence in the BOG has been mailed.

#### IV. New Business:

A. One copy of the UCAN Services Agreement was circulated. Final version is quite different than the proposed draft (Evans). There is a provision for possible termination of employment of faculty who violate the agreement.

B. The Spring calendar is traditionally longer than the Fall, and for some classes this results in three to four more class days (Jorstad). However, classes that meet on Monday may meet an equal number of times (Kruse). Jorstad will prepare a comparative calendar.
